- 2) By rectifying the first amendment previously made to the Articles of Association of the Company by a special resolution passed on 29th November, 2008 where clause (4e)(aa) of the Memorandum of Association was wrongly stated as Article 4(e)(aa) of the Articles of Association of the Company
